Superintendent Scott Grimes discussed building permits filed within the district. Superintendent Grimes discussed the proposed master calendar for 2019-2020. Superintendent Grimes reviewed elementary student transportation noting the success of the pay to ride program and plans to continue the service. Superintendent Grimes discussed the hire of Jill Van Woerkom, Associate Superintendent of School Improvement, posting for the activities director position, reading intervention position, high school media position, nurse position and middle school instructor position.

Superintendent Grimes discussed construction and planning of facilities. He also reviewed the upcoming DCG Foundation 3rd Annual Fundraiser Breakfast to be held Friday, February 15^a with keynote speaker Sarah Noll Wilson.
