RSP & Associates enrollment projection and analysis

Mr. Rob Swartz of RSP Associates provided the Board with an enrollment analysis and projection. Projections currently indicate an enrollment increase of 3.6% to 4.8% over the upcoming five year period. It was noted that capacity challenges will occur until the opening of the new middle school in 2021-22, and it is important for the Board to consider future high school capacity in the next five years.

DC-G Education Foundation Annual Presentation

Several members of the DC-G Education Foundation presented information to the school board regarding the success of the Foundation in the last year and exciting plans for the upcoming year. Mitzi Chizek

Associate Superintendent of School Improvement Report

Mrs. Jill Van Woerkom, Associate Superintendent of School Improvement discussed summer activities to improve instruction including a team attending the PLC Conference, and a two day training session, Self-Assessment of MTSS Implementation (SAMI), attended by many staff. She also discussed new teacher orientation planning currently underway, and all staff days at the beginning of the year August 19-22. She noted that we are pleased to include Dr. Joe Sanfelippo, Superintendent of the Fall Creek School District and winner of the Innovative District award in 2016 and 2017, in our school year kickoff presentation to staff.
