Public Hearing for the proposed budget for the 2021-2022 fiscal year

President Rants stated, "This is the time and place for the public hearing and for meeting on the matter of approving the 2021-2022 Dallas Center-Grimes Community School certified budget. Are there any questions, comments, or objections from those present?" No one responded. President Rants asked, "Michelle Wearmouth, as Board Secretary have you had any objections or comments filed in the Secretary's Office?" Mrs. Wearmouth indicated that no objections have been filed. President Rants declared the hearing on approving the 2021-2022 certified budget to be closed.

Building Level Report

Elementary Principal Diann Williamson and April Heitland presented on living the District model through the pandemic. They reviewed the curriculum and instruction, environment, relationships, and technology and discussed each of the adaptations that have been made in 2020-21.

Associate Superintendent

Associate Superintendent Jill Van Woerkom presented information regarding Iowa Statewide Assessment of Student Progress (ISASP) which will begin April 1, 2021. She also discussed professional development held March 3, 2021 for ISASP test administration training. There will also be professional development on March 31, 2021 for ISASP planning.

Superintendent Report

Superintendent Grimes discussed COVID-19 items and data from over the last year. He reviewed online considerations for the upcoming year.

Superintendent Grimes reviewed 2021-2022 transportation and bell schedule noting that Oak View will start 30 minutes earlier than other facilities. This change reduces five bus routes. He noted that there would be some gap activities after school.

Building permit numbers were reviewed noting 24 new permits for a total of 149. He also reviewed class size guidelines and the recommendation to continue the same maximums in 2021-22. He reviewed the most recent staffing update and enrollment projections. Superintendent Grimes updated the Board on facility construction, facility naming, and plans for high school / Meadows.

Business Manager Report

Business Manager discussed the public budget comparison report and the revenue and expenditure report for the month of March 2021. Mrs. Wearmouth reviewed the proposed budget amendment for the 2020-21 fiscal year in the support services area primarily due to costs associated with COVID-19 mitigations. Mrs. Wearmouth reviewed the Moody's rating of March 17, 2021 at Aa2, and discuss bond bids received today. Finally, Mrs. Wearmouth reviewed the USDA recognition received of our food service program's efforts in the summer feeding program.
