Building Level Reports

Principal Debra Cale, Principal of Dallas Center Elementary, discussed social emotional learning data. She reviewed historical FAST testing data, and reviewed other assessments. She also discussed preschool and early childhood special education preschool. She reviewed curriculum surrounding social emotional learning purchased specifically for preschool.

Associate Superintendent Report

Associate Superintendent Jill Van Woerkom presented updates to the Board on state reporting via the Fall BEDS Staff due October 30, 2021 and SRI Student Reporting in Iowa which was submitted October 15, 2021. She also reviewed updated information on professional development held on October 6 and October 20, 2021. She discussed development and implementation of the computer science plan, including trainings and meetings of the computer science team.

Superintendent Report

Superintendent Scott Grimes discussed building permits filed within the district. Superintendent Grimes presented an update on COVID-19 data and mitigation strategies in the school. He stated that we will be working with our counties to provide vaccinations for students if that vaccine should be authorized. Superintendent Grimes discussed Social Emotional Behavioral Mental Health and Diversity, Equity and Inclusion training in the District stating that it has been discussed at both SIAC and DLT Meetings in October to receive input and feedback around SEBMH and DEI. He stated that he is currently in a cohort with other Superintendents that is working with the RIDES Project, Reimagining Integration: Diverse and Equitable Schools at the Harvard Graduate School of Education. He stated that next steps include formation of a district level committee that will occur with both administrative and teacher members. This will function in a similar manner to the Safety Committee and DLT and will be led by the Superintendent. Board members asked questions about these committees and communication.

Superintendent Grimes reviewed progress on the planned high school addition and renovation. It included meetings with the architect and mechanical contractors for this project as we move forward in the design phase of the building noting that the plan is to complete in two years. He discussed plans for turf options as well as fire suppression systems.

Superintendent Grimes discussed the 2021-2022 Certified Enrollment count noting that the certified enrollment count increased by 170.7 students and the served count increased 127.92 students.

Superintendent Grimes reviewed the upcoming 2021 IASB Convention and Delegate Assembly to be held November 17 and 18, 2021.

Business Manager Report

Business Manager discussed the public budget comparison report and the revenue and expenditure report for the month of October 2021. Mrs. Wearmouth also presented a summary of IASB Fiscal facts for FY21 including revenue/expenditures comparison, enrollment comparisons, and unspent balance, solvency, and fund balance information.
